I would like to thank all of the Governmental Relations Committee (GRC) members for their dedication and willingness to work hard as we begin a new legislative session. Current committee members are as follows: Jacquella Payne (SS) – Chair, Elaine Koomia (SD) – Vice Chair, Sylvia Carlson (SS), Ann

De Jarnatt & Jill Van Droff (BC), Melissa Locketz & Becky Brunswick (N), Barbara Rose (CC) and Beth Berthold (CV).

The CSNO Governmental Relations program is a comprehensive legislative advocacy effort; providing a full range of legislative, grassroots and political activities on behalf of the Organization and its members. The program is governed by existing policies and procedures developed and adopted by the CSNO Board of Directors.

In 2019, GRC held several telephone conference calls. 21 California bills were reviewed, discussed and monitored. GRC sponsored AB 258 (Jones-Sawyer) and AB 1322 (Berman). With member advocacy, as well as collaboration with other supportive organizations, GRC was able to move these two bills all the way to the Governor's desk where they were unfortunately vetoed, however we will continue to move forward. The 2020 legislative session began January 6, 2020 and we are in the 2nd year of a two year cycle.

You can support GRC by visiting your Legislators. Establishing a relationship with your legislator prior to asking for his or her assistance is helpful. Your legislator will view you as a professional and an expert in school children's health. Legislators or their staff members are more likely to call upon you for an inside perspective when they have questions. Take time to visit your legislators in their home offices. It is easy as 1-2-3.

1. Make an appointment or visit a calendared event. Plan your visit for no more than 15 minutes.
2. Share your business card.
3. Offer yourself as an expert in children's health so that your legislator can call on for assistance.

GRC is provided guidance and leadership from our lobbyist Lydia Bourne. Lydia represents CSNO in Sacramento and is the foundation of the GRC committee. Through her tireless efforts and advocacy CSNO legislative effectiveness is enhanced.

As I was reviewing CSNO materials from a past conference I came across something that caught my eye. It was from CSNO and it stated, "Who attends the yearly CSNO conference?" Out of interest I read it and these were the key points: 1) networking,

2) research and evidenced base practice, 3) measures to promote health, 4) multidisciplinary strategies to address wellness issues and 5) access to utilize additional resources through sponsors and exhibitors. I thought to myself; yes, those are the reasons I go every year and enjoy not only the professional growth that it provides but also the camaraderie of seeing numerous school nurses and others that are part of our school nurse community. Networking is always such a pleasure.

In focusing on one other aspect of this list of objectives I would choose, research and evidenced base practice. One of the most important areas of growth, for not only CSNO but for many professional organizations, has been the rise of the technological age that we live in. Research and evidenced base practice are so much more available on-line than what we had not that many years ago. There are laws, education codes, journals, books, multiple hospital resources, etc., all on-line. All of this gives us access to learn about measures to promote health.

In working with the Green Book team from all over California it became very evident to me that this project encompassed a special part of the core of school nursing. I found this best expressed in the first statement in "The Concept of Competence" about school nursing from the National Association of School Nurses. The first sentence states "An expected level of performance that integrates knowledge, skills, abilities and judgment." I saw that level of competence in the Green Book team. As some of the modules are nearing completion they will reflect a part of this competence from the many who have served. This time, the Green Book will be available in separate modules, such as asthma, catheterization, oxygen, gastrostomy tubes, tracheostomies, etc. As the modules of the Green Book are produced it will be up to each school nurse to choose which modules they will need in their school nurse practice. Do you have children with catheterizations, asthma and Gastrostomy tubes? Instead of purchasing the whole of the Green Book, you will be able to purchase just the modules you need. You will have the researched information that you can utilize for multiple needs in your practice such as IHP's (Individual Health Plans), nursing diagnoses, outcomes and teaching tools from the procedures and other information provided. Modules will greatly assist you as you facilitate, discuss in groups, utilize audio-video and provide hands on experiences in your schools with the Green Book as a guide.

High praise and many thanks go to all of those who have contributed their professional experience and time to the Green Book modules. Some modules are nearing completion, and I have seen some of the work done by Belinda Braeger, Editor of the Green Book. I am absolutely stunned by what I have seen. Each of you as a school nurse brings special gifts to our practice. School nurses really do "Rock."

State School Attendance Review Board (SARB)

School attendance review boards (SARBs) meet regularly to diagnose and resolve persistent student attendance or behavior problems. The State SARB submits annual recommendations to provide the State

Superintendent of Public Instruction with guidance about potential actions to support schools in improving student attendance and reducing the number of dropouts. The goal of SARBs is to keep students in school and provide them with a meaningful educational experience. SARBs are composed of representatives from various youth-serving agencies. They work together to help truant or recalcitrant students and their parents or guardians solve school attendance and behavior problems through the use of available school and community resources. Review Boards (SARBs) at the local and county level create a safety net for students with persistent attendance or behavior problems.

The California Department of Education (CDE) has been exploring the possibility of excluding "medically fragile" students from the chronic absenteeism rate. Currently, the CDE does not collect this data in the California Longitudinal Pupil Achievement Data System (CALPADS), nor is there an existing definition in the California Education Code for "medically fragile." CDE met with several stakeholder groups on this issue—including the California Practitioners Advisory Group and the Advisory Commission on Special Education. Should students who are medically fragile also be excluded from the count of chronic absentees? If so, what definition of medically fragile should be used to verify a student meets the definition? CSNO's medically fragile definition was shared.

After a discussion with the CDE's legal counsel, it was determined that the legal definition of a chronic absentee does not currently allow acceptable exclusions. A "chronic absentee" has been defined in Education Code Section 60901(c)(1) as "a pupil who is absent on 10 percent or more of the school days in the school year when the total number of days a pupil is absent is divided by the total number of days the pupil is enrolled and school was actually taught in the regular day schools of the district, exclusive of Saturdays and Sundays." Section 60901(c)(1) of the Education Code, which defines "chronic absentee", does not allow for exclusions of particular types of absences including absences due to chronically medical conditions. An amendment to this section of law would be needed to allow acceptable exclusions. Accordingly, the CDE will continue the current practice of including medically fragile students in the chronic absenteeism rate.

Annually, counties and districts may apply to be recognized as a model SARB program which identifies outstanding results-based school attendance improvement programs that provide comprehensive services to high-risk youth with school attendance or school behavior problems. <https://www.cde.ca.gov/ls/ai/sb/modelrecognition.asp>

Pupil Services Coalition

As part of the Pupil Services Coalition (PSC), CSNO has been working with other Instructional Pupil Support Personnel (IPSP) to urge for lower staffing ratios of school nurses, counselors, psychologists in schools. The PSC met with State Superintendent of Public Instruction (SSPI) Tony Thurmond to discuss ratios and workload. Additionally, the PSC has partnered with the ACLU in advocating for equitable student access to student support personnel. The ACLU will be presenting and have a booth at the CSNO conference. They want school nurses to share their stories about caseloads and the services provided to students in school. We believe this partnership will help lower the ratios for school nurses while expanding access to school health services. Additionally, CSNO, in partnership with the PSC, has been presenting at ACSA conferences advocating for lower ratios of school nurses to students. Attending these conferences include Dawn Anderson, Pamela Kahn and myself. We have been able to connect with administrators in sharing how school nurses impact chronic student absenteeism rates.



Sheri Coburn, Ed.D., M.S., R.N.

LEA Medi-Cal Advisory Ad Hoc Committee

CSNO has been at the table, along with many other school nurse attendees, to advocate for the Center for Medicaid and Medicare Services (CMS) approval of the State Plan Amendment 015-021. At the December 12th meeting LEA Medi-Cal Advisory Workgroup meeting, the Department of Health Care Services (DHCS) Safety Finance Division reported that all of the requests for additional information (RAI's) from CMS had been answered. What this means is that CMS is sufficiently satisfied with the State Plan Amendment that has been submitted and the responses DHCS has provided. Given this information, the SPA will be reviewed by DHCS legal team and then officially submitted to CMS. Once officially submitted to CMS, then CMS has 90 days to respond to the submitted SPA. We are awaiting positive news sometime around February/March 2020 that CMS approves the SPA. In the meantime, districts and county offices of education should be gearing up to implement Random Moment Time Survey (RMTS) as part of their interim claiming for the LEA Medi-Cal Billing process. Districts and county offices of education will need to participate in both programs since elements of the RMTS will be used to settle up in the interim claiming process. CSNO will continue to be involved in the SPA 015-021 rollout.

CDE Student Mental Health Policy Workgroup

In 2004 Proposition 63, The Mental Health Services Act (MHSA) was approved by California voters. The primary goal of the act was to transform the California public mental health system into a system that provides a broad spectrum of prevention and early intervention, treatment and support of infrastructure. The provision of school based mental health services provides appropriate student and family support in a safe and supportive environment while addressing barriers to learning. The MHSA supports the collaboration between education and mental health in assisting California's school students to achieve their educational and personal goals. Key resources and support information may be obtained from the CDE <https://www.cde.ca.gov/ls/cg/mh/mhresources.asp> Mental health services in schools includes a wide range of services, strategies and settings. Across the state, these vary across counties and

districts. The services covered through the MHSA may be provided by a variety of school personnel either formally or informally and include a) academic counseling, b) brief interventions to address behavior concerns, c) family counseling, d) suicide assessment and prevention, and e) referral to other systems.

The five major concepts of the MHSA include: a) client/family driven mental health system, b) cultural competence, c) community collaboration and support, d) integration of services, and e) major focus on recovery, wellness and resilience. Within California, there are several state agencies (including the CDE) involved in a variety of efforts that support the MHSA. Some of the accomplishments of the CDE Student Mental Health Policy Workgroup over the past year include:

- Collaborated with NAMI to increase the number of NAMI On-Campus Chapters on High School Campuses
- Continued to collaborate on updating the Youth Suicide Prevention Resource page with the most recent information for suicide education, prevention and post-vention, available at: <https://www.cde.ca.gov/ls/cg/mh/suicideprevres.asp>
- Embedded Student Mental Health specific language into the California Content Standards Health Education Section
 - o Analyze internal and external issues related to seeking mental health assistance
 - o Define four stages of mental health recovery (hope, empowerment, self-responsibility, and meaningful role in life) and demonstrate impact on complex mental health problems
 - o Describe common mental health conditions and why seeking professional help for these conditions is important
 - o Examine the role that natural supports such as spiritual organizations, community centers, and other community-related resources play in an individual's mental health recovery
- Partnered with NAMI and the BORN THIS WAY FOUNDATION to develop a Youth Mental Health First Aid training of trainers program and increase the number of educational staff (certificated and classified) who have completed a Youth Mental Health First Aid course

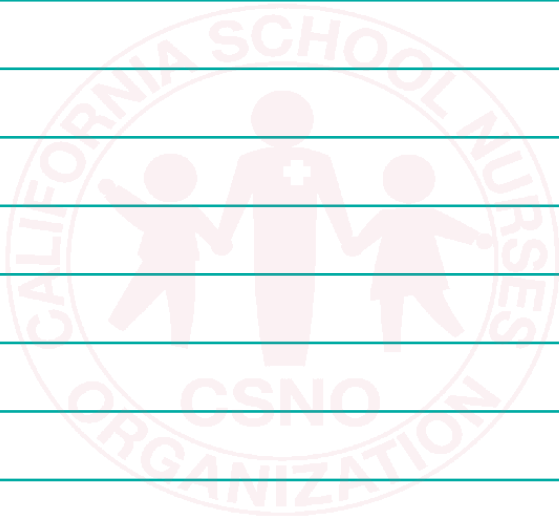

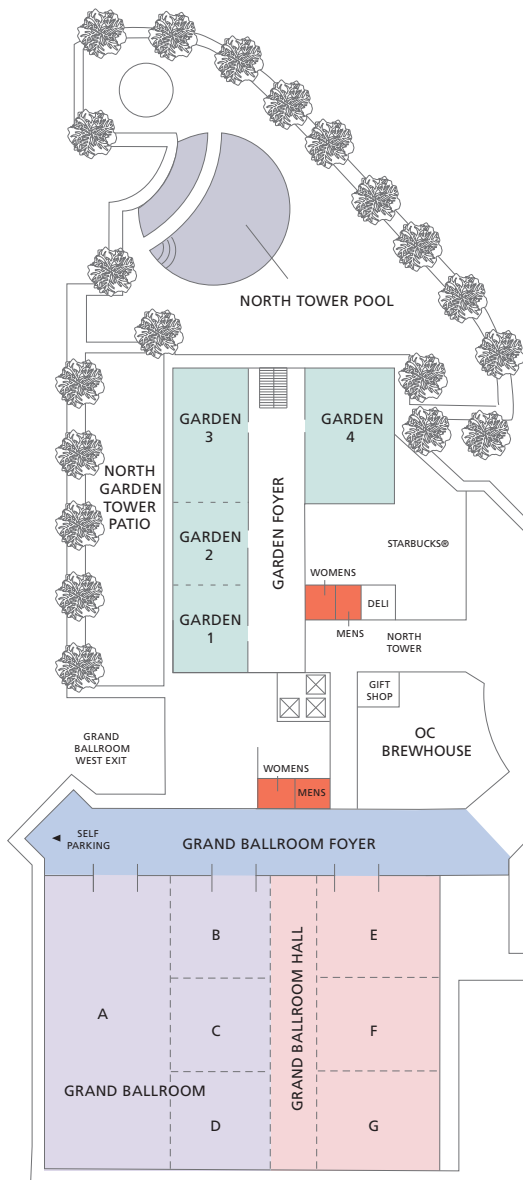
